***Please note that tuition fees and charges are subject to periodic review and may be increased by Sydney Met on an annual basis. Any increase will ordinarily take effect from the beginning of the subsequent calendar year. Students will be made aware of any changes to fees and charges prior to the revised fees and charges coming into effect. All students, including domestic and international students, are required to pay the current applicable tuition fees and charges that are in force at the time payment is due, regardless of the fees and charges that applied at the time of enrolment or commencement of study.
